A-1. Soccer Field Resolution

#### TRACE RIDGE OWNERS ASSOCIATION, INC.

### Rules Regarding License to Use Soccer Field for Organized Team Practices

WHEREAS, The Trace Ridge Owners Association, Inc. (the "Association"), acting through its Board of Directors, has authority pursuant to Article V, Section 5.3 of the Declaration of Covenants, Conditions and Restrictions for Trace Ridge (the "Declaration") to make reasonable rules and regulations for the Use of the Common Areas; and

WHEREAS, the Board has determined that there is a need to establish rules and procedures for Members/Residents of the Association to request a temporary license for the use of the Association Soccer Field for the Member/Resident's to coach their youth Soccer teams from the area.

**NOW, THEREFORE, IT IS RESOLVED** that the following rules regarding the request for a license to use the Association Soccer Field for Organized Team Practices (the "Rule Regarding License for Soccer Field") are hereby adopted by the Board of Directors.

- 1. Members/Residents, in good standing, who have resided in the Trace Ridge community for over one year, who have had no more than one complaint/violation of the Association restriction in the past year, and who coach a local sport team which includes at least one of the Member/Resident's children may apply for a license to allow their sport team to practice on the Soccer Field.
- 2. Members/Residents and their sport team will only be allowed to practice up to two (2) days per week at agreed upon specific times for the duration of the sport season.
- 3. Members/Residents cannot reserve the Soccer Field to the exclusion of other Members/Residents in the community, and Members/Residents and their sport teams cannot kickoff or otherwise ask other Members/Residents of the community to leave the soccer field or park area.
- 4. To obtain a license to use the Soccer Field, the Member/Resident making the request must submit a letter to the Board of Directors requesting the license and providing their name, mailing address, email, phone number, name of their child that is on the team and the name of the soccer team. Upon receipt and confirmation that the Member/Resident meets the other criteria stated above, the license will be presented to them for their signature.

IT IS FURTHER RESOLVED that this rule shall remain in force and effect until revoked, modified or amended.

This is to certify that the foregoing resolution was adopted by the Board of Directors at a meeting of same on May 2024, 2024, and has not been modified, rescinded or revoked.
